PENDING HEARING on the above Order to Show Cause, you, your agents, servants, employees and attorneys and all those in active concert or participation with you or under your instruction ARE HEREBY RESTRAINED AND ENJOINED from: interfering with the activities of Plaintiffs, herein, and those like situated persons and entities, who allege lawful compliance with California state law and the California Compassionate Use Act in the ownership, maintenance, leasing, renting or use of facilities within the state of California for the production, distribution, transportation, or use of medical cannabis under California state law as well as those persons, patients, collectives, cooperatives, and others who actually produce, distribute, transport and use medical cannabis lawfully under California state law.

The above Temporary Restraining Order is effective on Plaintiffs’/Petitioners’ filing an undertaking in the sum of \$ -0-. This Order to Show Cause and supporting papers must be served on Defendants no later than \_\_\_\_\_ days before the date set for hearing, and proof of service shall be filed no later than \_\_\_\_\_ court days before the hearing.
