**N.B.** [REDACTED] a national class action will be filed in the United States District Court in Philadelphia, Pennsylvania. Our firm is privileged to lead and direct this historic litigation by the people against the federal government.

Class action representative plaintiffs will represent all regions of the United States. Each of the representative plaintiffs have a specific and a typical need for marijuana as medicine.

Eight people in the United States are presently treated "compassionately" by the government. Millions are not. It is shocking that the government lacks compassion for the sick who need relief from pain and discomfort. This lack of compassion and basic inhumanity is manifested even though it is indisputable that millions of sufferers and their physicians have found that marijuana is therapeutic in treating AIDS, glaucoma, cancer, multiple sclerosis, epilepsy, chronic pain and a legion of other diseases, disorders, and syndromes.
